Large Event Contract

(Including Festivals, Corporate Events, etc)

\$130 per hour

2.5 hour minimum

\$45 deposit will be charged to reserve the date and will be applied as a credit toward the hourly rate.
Your date will not be booked until payment is received.

48 hour rescheduling/cancellation notice required to change the date to another available date/time
or cancel the event

a tip jar will be set out for events unless otherwise requested.

Setup for all Events

We will provide all necessary equipment to set up, paint, and dispose of our trash. For small private events our artist needs a 5' x5' area. Larger events may require multiple artists, equipment and a minimum of a 10'x10' area.

PLEASE NOTE FOR OUTDOOR EVENTS: - Space provided must be out of the elements (rain, splash pad, sprinkler systems etc) and in a shaded area or our face paint will melt and we are unable to paint. If a tent is required and you are not able to provide one, please let us know in advance.

If the event is outside during the fall/winter months please have a backup indoor area planned for us to paint in. Since we spray water to activate our paints we need to ensure that the paints do not freeze, if this occurs we will be unable to paint.

Breaks

Artists will have paid breaks of 5-10 minutes every two hours and access to a restroom.

Extreme Adverse Working Conditions:

Artist has the right to cease painting and leave without refunding any monies if there are extreme adverse working conditions and the client fails to remedy the situation after it has been brought to the client's attention. Adverse conditions included but not limited to : destructive, violent, or extreme inappropriate behavior of a child, pet, or adult illegal activities; or otherwise dangerous conditions.

Overtime:

Any time beyond the time booked will cost \$100 per hour, or \$50 per half hour, per Artist, with a full half hour charge being due for each 1-30 minutes of overtime. However, only booked times with deposits are guaranteed, additional time on the day of the event may not be available, although Artist will attempt to accommodate requests for additional paid time.

Travel/Setup/Other Fees

Travel Fees apply when the event is more than 30 minutes from Slinger, WI. Generally, \$30 per artist per half hour increment. Parking fees must be paid to Artist with other payment.

Should a check be returned, there is a \$30 returned check fee.

Policies:

Color Pop Paint is fully insured.

Face paints used have been designed for professional use and comply with all the FDA cosmetic regulations [As with any cosmetics, some people may develop sensitivity to one of the ingredients]. Many children are allergic to a wide range of common products. We are not responsible for any such reactions.

If you have any concerns regarding your child's reaction to face paints, please discuss with the artist BEFORE your child is painted. [Ask for a patch test half an hour in advance, and we will paint a small motif on the hand]

If your child has very sensitive skin or is ALLERGIC to COCONUT OIL or RED DYE, please inform the artist.

We will not paint anyone who, in the opinion of the face paint artist, appears to be suffering from : Cold Sores; conjunctivitis; any infectious skin complaint; open wounds, or similar. We will not paint children under the age of 2 years of age or that are under duress.

Artist will use reasonable care, but is not responsible for damage to clothing or property. The Client agrees to pay for any accidents or injuries caused by pets or guests, and/or damage to Artist's equipment or supplies caused by pets, lawn sprinklers, or guest.

Under no circumstances will Artists supervise children. Their behavior and safety is the Client's and/or Parents' responsibility.

To REMOVE face paint: gently massage a no tears baby shampoo or gentle soap onto the design and blot away with a wet washcloth or gentle baby wipe. If paint remains on the skin after being washed, use lotion or coconut oil to gently remove.

CLOTHING that has been in contact with face paint should be COLD soaked overnight with an oxygen activated stain remover before washing normally.

This contract does not go into effect until the deposit is received to secure your date and the Google form attached to the clients booking email has been submitted; all dates and times are agreed upon by both parties. Full/final payment must be received upon our arrival to paint. Color Pop Paint looks forward to making your event special and memorable.
